JOINT NOTICE AND MOTION FOR ENTRY OF TEMPORARY INJUNCTION

Plaintiffs League of Women Voters of Kansas, Loud Light, Kansas Appleseed Center for Law and Justice, Inc., and Topeka Independent Living Resource Center, and Defendants Scott Schwab, in his official capacity as Kansas Secretary of State, and Kris Kobach, in his official capacity as Kansas Attorney General, hereby submit this joint notice to the Court, advising it that the parties have conferred and are in agreement that the Court should enter a temporary injunction against K.S.A. §§ 25-2438(a)(2) and (a)(3) (the "False Representation Provision"). The parties accordingly respectfully and jointly request that the Court enter an order temporarily enjoining that portion of the relevant statute.

While the Defendants stipulate to the entry of a temporary injunction of this measure, they do not at this time stipulate to the entry of a permanent injunction. Accordingly, the parties also respectfully request that this Court schedule a status conference in this matter following the November general election. This will allow the parties to focus on preparing for the coming election and to confer regarding a joint proposal to the Court for resolving any remaining issues in this litigation.
